## **BEHIND CLOSED DOORS Capital Campaign Donor Recognition and SPECIAL EDITION Update**

The generous support of donors and friends – those who understand the importance of timely and efficient responses to child abuse and neglect reports, the need for effective therapy in preventing the long term consequences of abuse, and the role of prevention efforts in providing a nurturing environment for our children – has been critical in getting us to this point.

The Child Advocacy Center has never before attempted a multi-million dollar campaign. Thanks to the following donors, we have now raised close to \$5.3 million towards our total goal of \$6.5 million, which includes the \$500,000 awarded from J.E. and L.E. Mabee Foundation. Pledges made before or after the Mabee challenge was issued played a critical role in bringing the \$500,000 from Tulsa, Oklahoma, to Kansas. We are grateful to our donors for being heroes for the children of our community and look forward to a continued relationship.

The proposed new facility will have room for all our primary partners, including advocacy services, separated areas for victim and suspect interviews, ICT-S.O.S., Internet Crimes Against Children, additional space for therapy, prosecution and medical services, and a training area for professional and community education and prevention efforts. All these efforts are essential in providing services to the nearly 2,000 abused or neglected children seen each year.
